

## Location Description

### How to get to our office coming from Dubai?

Coming from Dubai Airport please take the exit at Rashidiya and follow the signs for "Sheikh Mohammad Bin Zayed Road (E 311)" towards Sharjah. Continue on Sheikh Mohammad Bin Zayed Road (E 311) until it ends in Ras Al Khaimah (about 100 km from Dubai).

Sheikh Mohammad Bin Zayed Road ends in a roundabout. Take the first exit (turn right) towards Ras al Khaimah. Follow the road and pass the two flyovers (bridges). You will come straight ahead to another roundabout (on the left side before the roundabout is a Adnoc gas station).

Go straight through this roundabout and now you are in RAK City with some street-side shops. Continue straight and take the first U-turn. Then, on the opposite side of the street, pass the Al Dana Furniture and Emirates Market. You will see a white and brown building with an ice cream parlor and a black building with a sport nutrition shop on the corner. Turn right into the road just behind these buildings. You will see our entrance gate with our signboard straight ahead. You can park directly in front of our office.

### How to get to our office coming from RAK City, Nakheel or Musandam?

Take the main road towards Dubai. After the boat roundabout you will come to a traffic light. Please continue straight ahead. You will see the bright yellow Al Dana Furniture building and Emirates Market. Then, there is a white and brown painted house and a sport nutrition shop. After this building, turn right toward the beach and continue on this street until the end. Our office is now in front of you. Our signboard is just outside on the wall. You can park in front of our office.
